Due to judging limits, we cannot guarantee that all requested transfers can be accommodated.

All classes with jumps in all trials will run in ascending catalog order.

As a courtesy to our exhibitors, in classes without jumps, every attempt will be made to assign catalog order as if the class was ordered by jump height.

All competitors, through entry in this event, waive any and all rights relative to photo/video broadcast of this event. Competitors shall have the right to videotape/photograph portions of this event for their personal use only. No portion of this event may be videotaped/photographed for commercial or other purposes. #### **NO INDOOR CRATING**

Crating restrictions make for a more pleasant experience allowing more room for the dog and handler to warm up and less distractions both during warm-up and in the ring. There are no bottlenecks trying to get past groups of people.

#### **Dogs Eligible to Enter**

This event is open to all dogs 6 months of age or older who are registered with the American Kennel Club (including mixed breeds) or are a registerable breed who has obtained an AKC, ILP, PAL or Canine Partners number, except bitches in season, aggressive dogs or dogs suffering from any deformity, injury, or illness which may affect the dog's physical or mental performance. Dogs who are blind will not be eligible. No dog will compete if it is taped or bandaged in any way or has anything attached to it for medical purposes.

#### **ENTRY LIMITS**

Entries will close as follows:

RALLY: Entries will close when 60 entries for each trial has been reached.

**OBEDIENCE**: Entries will close when **7 hours** of judging has been reached.

A WAIT LIST will be established for these trials to fill openings created by entries that are withdrawn prior to the closing day. The full entry fee will be refunded to an entrant whose entry is replaced by a wait-listed entry.

If due to entry limits an exhibitor cannot be entered in both the Advanced B and Excellent B classes, the RAE class will be considered closed.

If due to entry limits an exhibitor cannot be entered in the Advanced B, Excellent B and Master classes the RACH class will be considered closed.

If due to entry limits an exhibitor cannot be entered in the Open B and Utility B classes the UDX class will be considered closed.

PREFACE. The sport of purebred dog competitive events distes prior to 1884, the gear of AKC's birth. Shared values of those involved in the sport include principles of sportsmanship. They are practiced in all sectors of our sport: conformation, performance and compenion. Many believe that these principles of sportsmanship are the prime reason why our sport has thrived for over one hundred years. With the belief that it is useful to periodically articulate the fundamentals of our sport, this code is presented.

- . Sportsmen respect the history, traditions and integrity of the sport of purebred dogs.
- Sportamen commit themselves to values of fair play, honesty, courtesy, and vigorous competition, as well as winning and losing with grace.
- Sportemen refuse to compromise their commitment and obligation to the sport of purebred dogs by injecting personal advantage or consideration into their decisions or behavior.
- The sporteness judge judges only on the merits of the dogs and considers no other fectors.
- The sportsman judge or exhibitor accepts constructive criticism.
- The sportsman exhibitor declines to enter or exhibit under a judge where it might
  reasonably appear that the judge's placements could be based on something other
  than the morits of the dogs.
- The sportsman exhibitor refuses to compromise the impartiality of a judge.
- The sportsman respects the AKC bylens, rules, regulations and policies governing the sport of purebred dogs.
- Sportsmen find that vigorous competition and civility are not inconsistent and are able to appreciate the merit of their competition and the effort of competitions.
- Sportsmen velcome, encourage and support newcomers to the sport.
- . Sportsmen will deal fairly with all those who trade with them.
- Sportsmen are willing to share honest and open appraisals of both the strengths and weaknesses of their breeding stock.
- Sportsmen spurm any apportunity to take personal advantage of positions offered or bastowed upon them.
- · Sportsmen always consider as paramount the welfare of their dog.
- Sportsmen refuse to emberress the eport, the American Kennel Club, or themselves while taking part in the sport.
